Library Vision Grants

ND Library Coordinating Council met on November 8th, 2021

\$141,893.00 was awarded in 3 categories (Collection Development, Marketing, Local History)

Marketing Grant phase 2 will be released in July or August 2022

Library of Things Grant in October 2022

For the first time, the Coordinating Council allowed libraries to use a collection development grant towards adding materials to the 2 e-book consortiums (public & school). Unfortunately, no one took advantage of it.

2:32pm Planting Book Seeds...and Reaping the Financial Benefits (Phyllis Kuno)

TBI had 25,000 books and many boxes of journals, so they needed a plan to get rid of them

Started selling their weeded/discarded books to My Empty Shelves, Better World Books, and Amazon to make extra money.

My Empty Shelves pays \$2 per book. Earn around \$55-\$60 per box.

Have earned \$1,100 since 2017 with Better World Books. They pay shipping, send free labels & boxes, and all we have to do is print the label & tape up the box.

Earned \$11,500 since 2017 with Amazon book sales. Sold 450 books at an average of \$26 per book.

\$200-\$400 from books sold locally.

Total fund has around \$13,000 in it and has enabled us to buy things we need that weren't in the budget

3 steps – Collect information. Create information slips/labels. Make your decisions.

Created a database to track all needed information and generate labels from that information

Places to "plant your book seeds" – Sell at home, Better World Books, My Empty Shelves, Amazon, Donate to a good cause, Give away on "free" shelf, Recycle (last resort)

ECOR is NDUS trying to have online courses available to students at NDUS schools that are free from textbook costs. Instead, they can use OER, library resources, open internet resources, or any other free resources. Ultimately, up to instructors what can be used.

Some classes will be ready this spring and Staci is their Library Representative

They want creative solutions and libraries involved to make materials accessible to students in a consistent way. Staci believes Leganto is a good solution.

NDI currently using Leganto

Benefits include:

Alma/Primo VE integration

Allows use of licensed library materials as well as OER and web resources to lower textbook costs

Can increase usage of library resources by students & instructors

Can manage copyright

Can pull library resources and other links out of Blackboard to cut down on Blackboard storage costs

Librarians can become involved in research, teaching, and learning. Increases collaboration with instructors.

Continuity for students across campuses in accessing course materials

Strong analytics

Challenges include:

Still some issues with links, need to be checked

Faculty is tired of technology changes

Library buy in or interest

Learning curve for the software

Staffing challenges for smaller libraries to create, promote, and develop product

Cost of the product (possible funding by federal dollars)

Put forth an idea of a possible ECOR/OER sub-committee for librarians so we can be prepared and show as a unified group in ND

Are the Tribals and University of Mary involved? Staci is not aware of them being involved.

Staci believes we should start with assembling an NDUS/ODIN sub-group, then seeing what ECOR wants. A big opportunity for us to be involved.

Katie Wenke asked if this program would mean a statewide distance learning opportunity instead of each institution having their own distance programs. Staci believes this would be the case for core classes. The textbook for the class would be an open resource.

Staci suggested talking to the ECOR rep on your campus to learn about grants to fund distance courses and make them more accessible as ECOR courses.

The vision is to create, promote, and provide ease of access to ECOR courses and materials. Make it system-wide availability. Want to assemble a pool of instructional designers and librarians to provide in person support along with building online instruction modules to demonstrate tasks to students and faculty.

Staci believes it's a big opportunity to show administrators our worth

Stephanie Walker expressed they are already using OER materials for courses at UND, but there is no central repository of what materials are being used and who is using them. She said this would be a good next step for them in creating a collection or permanent record of these OER materials. However, copyright and licensing need to be taken into consideration when sharing materials. Plus, instructors are hesitant to have to learn another new piece of software.

Katie mentioned a staff shortage at their campus. She has to be the librarian on top of her full time job and doesn't know if she would be up to or have the time to learn a new system.

Stephanie said UND doesn't have an OER librarian. She's doesn't have the time to set up reading lists.

Tuya Dutton wanted to clarify that ECOR is, in fact, happening. Staci says yes. Their goal is for some classes to be offered this spring.

Tuya expressed concerns about allocating staff time that is already stretched and that sharing services would eventually cause an unintentional effect of losing staff positions.

Staci said they are able to do it as a 3 person library though there are challenges. This program could benefit smaller schools because students would have opportunities to take classes that they may otherwise have to transfer schools to take.

Ellen suggested pooling resources and using several Leganto instances for everyone rather than everyone having their own. Then, ODIN could add staff and take on some of the responsibility, or one library could add a position, and that person would work on behalf of all libraries.

Staci says there's an example of a consortium in Norway doing something similar.

Ellen suggested getting together the core group of people to figure out specifics, then take them to the group via email. Suggested names: Stephanie Walker, Kelly Kornkven, Staci Green, Jennifer Jenness, Sandi Bates, Catherine Kratochvil

Ellen would like more research done on ECOR and its funding

Staci said there's a lot of federal funding over there to work together and take advantage of

Ellen & Staci will work together to draft an email to the core committee. Goal will be to make sure all the academics are informed of the process. Will also work to find some products.

Marlene Anderson (NBJ) – Library now has the Book Bean coffee bar. Had a soft opening and 3 baristas are currently training. Haven't set hours yet. Jennifer Jenness (NDV) – Trying to come up with ideas to engage students and bring them into the library. Also trying to encourage them to be aware of public health restrictions. Has been a challenge. Planning for Destressing before finals and keep ourselves destressed. Got the work room somewhat clean.

Erika Johnson (UNF) – Teaching and working with students. Finished interviewing candidates for their Southeast Clinical Campus position.

Jane Laplante (NMI) – Susan Padraguler retired in August after 41 years. They have an opening for an Electronic Resources and Collection Management Librarian. An anonymous donor gave funds for new Scan Pro 3000. Applied for HEERF (Higher Education Emergency Relief Fund) funding to purchase Canopy streaming service for 1 year.

Phyllis Kuno (TBI) – Jessica, Phyllis's assistant, is having a baby boy on December 23rd. School is debt-free. New financial officer is trying to keep it that way. Put a crunch on library staffing. Excited about a library annex happening after some remodeling. Students are painting rocks and hiding them all over the library. Very fun.

Stephanie Walker (UND) – Grand opening went well. Around 100 people. Had a small flood immediately afterward, Sally's office and the Gov. Docs. office were affected. No collections were affected. Lots of tours and visitors. Searching for an Engineering Librarian. First attempt was unsuccessful. Will be advertising for it again in March 2022. Send anyone with academic library experience their way. Laura Egan will train on Engineering resources.

Wendy Wendt (NGF) – Kirsten, their executive administrator, moved to Arizona. New Exec Admin started yesterday. Doing some other hiring as well. Applied for ECF (Emergency Connectivity Fund) Grant. Michelle won a scholarship to go to the ARSL Conference for the first time and will have an article included in the Arsal newsletter. Finished up Arsal grant on veteran's issues.
