ODIN DIRECTOR REPORT - Stukel

The upgrade to ALEPH version 20 was completed on schedule this past June fourth. This is our third major upgrade. It went very smoothly.

A update of the ODIN web site was completed and went live in August of 2010.

A new version of UFind was put in place this past September 2010. Functionality includes:

- ILL functionality in ALEPH without 'leaving' the UFind interface.
- Will be removing 'comments' tab since there has been no use in over a year.
- Course Reserves is new functionality that needs to be configured to use.

Directors shared experiences regarding the UFind interface in their libraries.

ODIN staff has worked on a Federated Search proof of concept using Pazpar2 open source software. It shows significant promise. It has not been carried beyond the initial stage at this time. Showed the basic search capabilities that had been developed to date. The work done to date shows that federated searching can perform well in terms of response time. ODIN participated in a meeting MNPALS set up with Index Data about management tools for Pazpar2.

ODIN training materials have been re-worked and material has been added. We have begun producing brief training videos. Planning to add at a one a week pace. ODIN is looking for ideas from the user community.

Many custom reports are now available. Custom reports creation will continue as needs are identified.

ODIN is loading records for libraries. Vendors include; Credo, NetLibrary and OverDrive at this time.

Loading of invoice records is in test. The testing process is being done with UND at this time. The process should be similar for other libraries who wish to load invoices.

Database Authentication Pilot/investigation. ODIN has been testing with EZProxy to enhance or replace the Authgate database screening process that is now in use.

Active Directory is coming to all NDUS campuses. Note that it is either 'on' or 'off' in ALEPH so the login screen will change at some point in the future. However, for non-NDUS libraries the process of logging into the library system for their users should not change. The login process will use the original barcode if that is what is put in for a login.

ODIN Hardware Environment. ODIN updated Virtual Machine software within the last month. All ODIN servers except ALEPH servers run in a virtual environment. We can add servers as we need them. We can also change the resources available to any given server to increase capacity if needed. Current servers include:

- Drupal Test
- MySQL
- SMTP Email Gateway
- UFind Production
- UFind Test
- Pazpar2

The following servers provide ALEPH services.

- Libserv4 ALEPH Production
- Libserv3 Oracle Production
- Libserv1 ALEPH Test
- Libserv5 Oracle Test

No changes in staffing to report. Expect to fill one open position to improve our ability to move quicker and to provide some depth/backup in the technical area.

Going to propose changes to the patron configuration to considerable improve patron 'sharing'. This will provide a substantive project for the circulation work group. The project is to bring back the general ALEPH USER.

ALEPH Upper Midwest User Group will be held in FARGO in October of 2011. This conference was planned to be in North Dakota to make such a meeting more accessible to ND libraries. Has been in St. Paul last three times. Hope you can support this effort.

NDUS Update - Stukel

The move from multiple email systems to a single system called BPOS is underway for the NDUS. Expect to complete the move of all campuses by summer of 2011.

Annual Survey next spring should be briefer and more focused.

ODIN will be working to enable the library system to use the Active Directory process currently in progress for NDUS. We have just begun testing the process.

1901.3 Information Technology Approval Process is in force for the North Dakota University System. The introduction says:

NDUS Policy Section 1901.3 states:

Consistent with North Dakota Century Code section 15-10-44, the state board of higher education shall manage and regulate information technology planning and services for institutions under its control. The Chancellor is delegated authority and directed to develop information technology planning, policies, standards and guidelines, and project management oversight and reporting in conjunction with the state information technology department. NDUS Information Technology (IT) projects shall comply with established standards, guidelines, procedures and processes.
