**SMS Solution** – Shout Bomb – Resolves the issue with minimal cost – adds some patron interactions – Message will come from a single, toll-free number – Text to email is no longer widely supported.

**Polaris System Outages** – Identified the source of the issues being 3<sup>rd</sup> party integration in the PAC. Vendor tweaked the integration to only run between 12-6.

May Release Notes – Classic Title UX will sunset with the 2025 August release, Manage Patron Services and Return Items new UX Now default version. AZ List of database and journal search pages is back. Both AI Assistants are continually being improved. Add link-CERV Process (formerly NERS) – round 2 now open. Primo and Alma both have ballots. ODIN Discussion Friday, June 27 – 10:00 am.

**Email Changes** – Increasing security to mitigate SPAM and Phishing attempts. NDUS only impacted (for now). Email is now DMARC complaint - had to tweak the letters configuration to a single email address per institution. Further changes are expected this fall

**Academic Cost Sharing Formula Completed** – majority of members agreed to the formula outlined in the last OAC – will start with FY26 billing – Committee – Amy Carson, Sally Dockter, Tuy Dutton, Amanda Walsh, Phyllis Kuno, Nicole Murphy

**Meescan Consortia Purchase Update** – contract is now officially in place. Rolled in 3 existing customers (UND, NDSU and Grand Forks Public) – Optional contract to purchase from, If Anyone

**Academic Search Complete Renewed** – renewed as a statewide purchase through FY26 CTS/ODIN will cover 20% of bill.

### State Librarian Report

SERT – Minitex lead RFP database – MN, SD, ND – MN issues RFP – group together – MN – 4 ND reps and SD reps – ND taskforce chosen by application submitted to NDSL. ndsl-ld@nd.gov Minitex purchases that NDSL pays for July 1-June 30 – Britannica plus some others – due to federal funding questions – NDSL is not sure how things will proceed forward. If Federal funding is eliminated – NDSL does not know what the future looks like

for databases and ebooks. ODIN also contributes part of state funding that ODIN receives towards databases. Canopy access for one more year and will expire June 30, 2026. Mango Languages & Novelist will not be renewed. Tracking damage from storms that has affected libraries, please send emails to State Library if your library has received damage.
